CONTESSA DRILLING – PROGRAMME OF WORKS APPROVED

Further to Lodestar's announcement of 9th September 2014 providing details of planned RC drilling of the Contessa gold discovery and first-pass aircore drilling designed to test extensive surface gold anomalies along the Contessa Trend, Lodestar advises that statutory approval for the Programme of Work has been received and site preparation will now proceed.

The initial 5 hole (1,000m) programme of RC drilling at Contessa will test beneath extensive supergene gold mineralisation for a primary gold source and also provide crucial information on the geological setting of the mineralisation to assist future drill targeting.

Aircore drilling (5,000m) will target bedrock mineralisation within gold anomalies identified by recent auger geochemical sampling along the Contessa Trend and will extend auger geochemical sampling over the prospective Archaean host sequence (see Lodestar's ASX release dated 9th September 2014 for planned drill locations).

Drilling will commence once drill sites have been prepared, with an estimated start date during the week commencing 26th October, subject to contractor availability. The Company will advise the market at the commencement of drilling.
